Item 2.01: To confirm the minutes of the First Meeting of the Senate held on 22/11/2017.

Item 2.02: To review the Action Taken Report on the minutes of the First Meeting of the IIITA Senate held on 22.11.2017.

The members of the Senate took note of the Action Taken Report on the Minutes of the First Meeting of Senate.

Item 2.03: To be apprised of the temporary location of IIITL in IIITA campus premises at Jhalwa Allahabad.

The members received the information about the allocation of various classrooms, offices and cabins by IIIT-Allahabad on its Jhalwa campus to IIIT-Lucknow with satisfaction and desired to place on record their thanks to the Director, IIIT-Allahabad for the same.

The members further also noted the augmenting of the existing facilities with items like Projector, I-Card Machine, Laptops, Printer and Almirah etc. with appreciation.

Item 2.04: To be apprised about the sanction of various teaching and non teaching positions for IIIT-Lucknow

The members received the information regarding sanction of various teaching and non teaching positions and decided to await for the Recruitment Rules to be followed, requests for which had already been made by the Mentor Director to the MHRD, New Delhi.

Item 2.05: To be apprised of the appointments of the Guest Faculty Members on contract.

The members received the information as presented through the Agenda and external members expressed their desire to meet the appointed faculty (on contract) after the meeting.

Item 2.06: To be apprised about the status of the procurement of 150 Laptops.

The members received the information on the status of procurement of 150 Laptops as presented and ratified the procurements.



Item 2.07: To be apprised of the revised Fee Structure of the B.Tech in IT Program of the Institute.

The members received the decision of the Governing Body in the matter of tuition fee revision for IIIT-Lucknow students w.e.f the admissions to be made during 2018-19 batch and onwards.

Item 2.08: To be apprised of the Statutes as received from Government of India.

The members apprised themselves of the Statues as received from MHRD for being placed before the Governing Body of the Institute in its next meeting.

Item 2.09: To be apprised about the separate conduct of academic activities of the IIIT-L students w.e.f January' 2018.

The members received the information about the classes of IIIT-Lucknow students independently being conducted w.e.f. 01.01.2018 together with the arrangement of few academic and administrative staff from IIIT-Allahabad on part time monthly remuneration basis. That two supporting manpower through Manpower Agency would be hired ,was also received.

Item 2.10: To consider the adoption of academic Ordinances for regulating the academic activities at the Institute.

In the backdrop of the admissions made at IIIT-Lucknow starting from year 2015, the members:-

- (i) Ratified the implementation of prevailing Ordinances of IIIT-Allahabad upon the students of IIIT-Lucknow till date as per the practice so far.
- (ii) Resolved to continue with the existing Ordinances at least till the first batch of students graduated.
- Item 2.11: To consider undertaking modifications in the Course Structure applicable to IIIT Lucknow students.

The members resolved to adopt the course structure as presented before them through the Agenda alongwith the suggested modifications in its Seventh and Eighth Semesters.

Item 2.12: To consider and approve the Electives being offered to IIITL students.

The members went through the list of electives that were offered during the academic session January-June' 2018 to the 6th Semester IIITL students as per the Agenda notes. The Head (IT) present during the meeting, explained about the contents in various courses.

The members thereafter ratified the list of courses offered alongwith the courses that were chosen by the students currently.

Item 2.16: To consider the format of Grade Cards and Transcripts for B.Tech (IT) Program for the students of the Institute.

The members approved the format of Grade Cards and Transcripts to be issued to the IIIT-Lucknow student, as per the agenda.

Item 2.17: Any other Item with the permission of the Chair.

There being no other item, the members proceeded to visit the infrastructural facilities made available to IIIT-Lucknow students by IIIT-Allahabad and also to meet the faculty members involved with academic institutions to IIIT-Lucknow students.
