UTTAR PRADESH POST MATRIC SCHOLARSHIP 2019-20

All the students of IIIT, Lucknow are, hereby, informed that the portal for filling up online forms for UP Post Matric Scholarship for the session 2019-20 is open for the students from July,1st2019

In this regard, special attention should be paid to the following points :-

- 1) The Internet Copy of Income Certificate, Caste Certificate and Domicile Certificate with proper and complete details are only acceptable.
- 2) Fields for High School & Intermediate Roll No. and marks obtained, as well as Bank account details are NOT EDITABLE, hence these fields should be filled with utmost care.
- 3) Courses to be filled according to the list attached as Appendix 'A'. If the branch is not specified, leave the field blank.
- 4) The fee is to be filled according to the list attached as Appendix 'B'.
- 5) Hostel and Mess Charges are NOT to be included in the fees.
- 6) Students M.Tech and Ph.D. should not fill the form as they are already in receipt of Stipend from the Institute. If, they still fill the online form, it will be rejected.

The hard copy of the form, complete in all sense are to be submitted IN TRIPLICATE, along with TWO set of of all the necessary supporting documents to the Scholarship Unit, IIIT-Lucknow (Admin block), within next THREE working days of online filling of the forms.

PROCEDURE TO BE FOLLOWED :

After filling up the form online, take the print out of the DRAFT COPY and submit the same alongwith all the supporting document to the Scholarship Unit for offline verification.

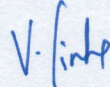

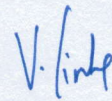
