Information Technology (IT)/ Computer Science (CS)/ Computer Science & Artificial Intelligence (CS & AI) Degree Program. We are delighted to welcome you to the IIITL family!

In view of the COVID-19 Pandemic, JoSAA2020/ CSAB2020 has decided that the admission process will be carried out in an ONLINE MODE at allotted Institute from 25th November to 1st December 2020 as per the notified schedule at CSAB portal for candidates who have accepted the allotted seat in JoSAA2020/CSAB2020 rounds. Candidates will be given provisional admission until the verification of original documents is done physically.

2. The admission fee for the first semester is Rs. 1,25,000/. JoSAA seat acceptance fee, partial admission fee, and CSAB participation fee, along with the seat acceptance fee, must be subtracted from this amount, as applicable. The processing fee is additional.

The fee must be paid through the SBI Collect Portal. For details of fee and its mode of payment, refer to page no. 2 & 3.
