Sen. Item 6.01: To confirm the minutes of the Fifth Meeting of the Senate held on 26/07/2020.

The Senate approved the minutes of the 5th meeting as were circulated on 11/10/2020.

Sen. Item 6.02: To review the Action Taken Report on the minutes of the Fourth and Fifth Meeting of the IIITL Senate held on 11/03/2020 and 26/07/2020.

The Senate took note of the Action Taken Report on the minutes of the 4th and 5th meeting of Senate and it was approved.

Sen. Item 6.03: To consider the names of Graduands of Batch 2016-2020 who are due to get their B.Tech. in Information Technology Degrees in the Convocation.

The Senate advised to form a committee to resolve the above issue. Senate Chairman IIITL forms a committee comprising of Dean(Academic) - Dr. Dhananjoy Dey Chairman, HoD(CS) - Dr. Soumendu Chakraborty, Faculty In-Charge Examination – Dr. Indira Mishra and Deputy Registrar – Dr. Vishal Krishna Singh to come up with the proposal to the Director IIITL.

Sen. Item 6.06: To ratify the Seat Matrix, Fee Structure and admission procedure for PG Diploma in Al and ML, PG Diploma in Data Science and PhD in Academic Session 2020-21.

The Senate ratified the Seat Matrix, Fee Structure and admission procedure for PG Diploma in AI and ML, PG Diploma in Data Science (Annexure 2) and PhD as presented by Faculty In-charge PG and Research for Academic Session 2020-21. It was decided by the Senate to prepare a PhD seat matrix and put up to the Senate for approval at the beginning of every semester. Senate suggested that Institute should explore the option of Scholarship/ Fellowship for their PhD students.

No student has withdrawn their admission from the batch 2020 of B.Tech. programme.

Sen. Item 6.14: To consider the change in the provision of Back Paper Exam.

After deliberating upon the changes in the back paper examination. It was resolved by the Senate that:

- Back Paper Exam of all the subjects will be conducted along with the regular semester exam (assignment/quiz+midterm+final exam) of the corresponding subjects starting from December, 2020.
- Special Back Paper Exam will be conducted in the month of May every year only for those courses which are discontinued due to change in the Academic Curriculum.
- 3. This is applicable for all existing and further admitted students of IIIT Lucknow.
- 4. The back paper exam of the subjects which are not being conducted in the current semester will be held in the month of January 2021. This is a onetime arrangement provided to students to clear their backlogs of previous years.

Previously the separate back paper exam was held once in a year in the month of July.

After due deliberation, Senate accepted the changes as above in the provision of Back Paper Exam.

Sen. Item 6.15: To consider the criteria/procedure for B.Tech. Project Evaluation.

The Senate considered the proposal received, discussed the proposed criteria/procedure for B.Tech. Project Evaluation for all semester and resolved that: Project Evaluation: It was decided that distribution of marks of the project will be as follows:

Mid-term evaluation – 40% weightage

End-term evaluation – 60% weightage

The Project Evaluation Board will be formed at the beginning of the semester in consultation with HoD's by Dean(A). The Board will evaluate the project and provide the marks. The Chairpersons of the designated board will finalize the marks/grade and submit the signed hard copy to the exam cell for records.

It was decided that the student should finalize their project title along with the name of the project guide in the beginning of the semester and the details should be submitted to the HoD office as per the schedule mentioned in the Academic Calendar. It was also resolved that from next semester; in the Academic Calendar the last date of submission of project details should exclusively mentioned. After the last date, 15 days will be given to students to submit the final project details. Penalty of 10% marks will be deducted in case students will not finalize the project details within scheduled time frame given in the Academic Calendar. No project will be accepted after the 15 days grace period and will be awarded F grade.

The administrative procedural flow related to project evaluation is follows:

- 1. After the HOD office collects the project details group details along with the boards will be communicated to the Exam cell.
- 2. It will be the responsibility of the Exam cell to distribute evaluation sheets to individual boards with a list of groups allocated to each board.
- 3. Chairman of the board will submit the evaluation sheet to the HOD office.
- 4. The respective HoDs office will submit the mid-term and the end term evaluation sheets to the Examcell.
- 5. End Term project reports will also be submitted to the Examcell.

Sen. Item 6.16: To consider the criteria/procedure for M.Tech. Thesis Evaluation.

After deliberating upon the joint proposal received from Faculty Incharge PG & Research, HoD (CS) and Dean (Academic). The Senate approved the criteria/procedure for M.Tech. Thesis Evaluation as in *Annexure 5*. The SGPI (Semester Grade Point Index) will be calculated excluding the thesis work. Student Passed in the thesis will be awarded 'P' Grade and Failed students will be awarded 'F' Grade. In case of student(s) secured 'F' Grade, will get a chance to clear the subject along with the regular semester exam of the thesis will be conducted.

Sen. Item 6.17: To consider and approve the proposed names of visiting faculty for teaching in MBA and PGDBM programmes.

The Senate suggested that this item is not relevant for the Senate and it may be placed before the appropriate body.

Sen. Item 6.18: To consider and approve the course outlines of second and third terms of MBA and PGDBM programmes.

The Senate viewed the course outline as presented by HoD(M&H) of second and third terms of MBA and PGDBM programmes was deliberated and approved.

Sen. Item 6.19: To consider and approve the commencement of Integrated Bachelor of Science (BS) in Management and MBA program.

After, due deliberations, senate accepted the proposals to start the Integrated Bachelor of Science (BS) in Management and MBA program with an intake of 60 students from Academic Session 2021.

Sen. Item 6.20: To consider the modifications in the Course Structure of B.Tech. and M.Tech. programmes along with course module details.

The course structure of B.Tech. programs (applicable for 2020 batch and from academic session Jan – Jun 2021 for 2019 batch) was presented to the members, which was discussed by them.

The Senate considered the proposal received from Dean (Academic), for revision in the course structures of B.Tech. and M.Tech. programs. Minimum 154 credits are required for completion of B.Tech. Degree and 72 credits for degree requirement of completion M.Tech Degree. 1 credit denotes 1 hour of theory/tutorial/2 hours of lab per week. While in deliberation the senate suggested that for M.Tech 1st and 2nd sem the credit for 'Competitive Coding' should be of two credits. In M.Tech 2nd Sem 'Artificial Intelligence' will be offered in place of 'Intelligent Agent and Planning', 'Data Mining and Warehousing' will be offered in place of 'Data Warehousing', there was a typo error noticed, 'Big Data Analysis' will be read as 'Big Data Analytics'.

After, due deliberation, senate considered and approved the course structures of B.Tech. (IT), B.Tech. (CS) and B.Tech. (CS&AI) and M.Tech. (CS) as presented in senate with changes as above. (Annexure 7 placed as separate file).

Sen. Item 6.21: To ratify the Academic Calendar for July to December 2020 offered programmes at IIIT Lucknow.

The Senate ratified the academic calendar of July – December 2020 as presented in *Annexure 6.*

Sen. Item 6.22: To apprise that IIIT LUCKNOW and FIRST, IIT Kanpur have agreed to enter into a Memorandum of Understanding to identify and nurture technology driven start-ups under the aegis of E-Cell, IIIT Lucknow.

The Senate noted the same.

Sen. Item 6.23: To ratify the change in course and new elective courses offered in B.Tech. (IT) 7th Sem in academic session July – December 2020.

After deliberation, Senate ratified the following changes in 7th semester course

- a) Convex Optimization in place of System Modeling and Simulation core course of 3 Credits, Theory.
- b) Intelligent Agent and Planning (Elective 3 Credits, Theory)
- c) Big Data Analytics (Elective 3 Credits, Theory)
- Sen. Item 6.24: To be apprised about arrangement of the common classes of M.Tech.

 1st year and PG Diploma conducted in Academic Session July December 2020.

The Senate noted the arrangements made for scheduling of the common classes for PG Diploma in Data Science, PG Diploma in AI&ML with M.Tech. (CS) 1st year students.

Sen. Item 6.25: To consider the maximum number of PhD students under a faculty member at a time along with Information Brochure for PhD admission, and advertisement for the PhD programme.

After due deliberation, the Senate resolved that a Professor can take 6 PhD scholar, Associate Professor can take 4 PhD scholar and Assistant Professor can take 3 PhD scholar maximum at a time. Senate also suggested that with the special permission from the Director, a PhD supervisor can take 1 extra PhD candidate ABOVE THE LIMIT.

The Senate approved the Information Brochure for PhD admission and advertisement for the PhD programme.

Sen. Item 6.26: To apprise the date of convocation for 2015 and 2016 batch.

The Senate noted the date for the Convocation and suggested to finalize the name of the chief guest for the forthcoming convocation.

Sen. Item 6.27: Any other Item with the permission of the Chair

There was no other item to be discussed. The meeting ended with thanks to chair.
