As per JoSAA2021 notification “The candidates whose documents have been verified successfully in any of the JoSAA Rounds (1 to 6) will find the option ‘ADMISSION AND PARTIAL FEE PAYMENT’ to deposit Partial Admission Fee in their login on JoSAA portal. The candidates are required to deposit the Partial Admission Fee COMPULSORILY, latest by 17:00 of November 24, 2021 on the JoSAA portal, to SECURE their admission.”

Candidates will be given provisional admission in IIIT Lucknow until the verification of original documents is done physically.

2. The admission fee for the first semester is Rs. 1,46,000/- (excluding hostel fee, and Electricity & Water Charges). JoSAA Seat Acceptance Fee and Partial Admission Fee must be subtracted from this amount, as applicable. The processing fee charged by JoSAA of Rs.2000/- is additional.
