- 1. Preference will be given to 'Persons with Disabilities', even where reservation is not marked in the table given on 1st page of this advertisement, if suitable PwDs are available.
- 2. (a) The Institute reserves its right to place a reasonable limit by putting a certain criterion on the total number of candidates to be called for written test / interview.
 - (b) Merely fulfillment of qualifications does not entitle a candidate to be called for test or interview.
 - (c) The Institute reserves the right not to fill up the posts, cancel the Advt. in whole or in part without assigning any reason and its decision in this regard shall be final.
- 3. The Institute follows the reservation norms as per GOI rules for SC/ ST/ OBC/EWS and PwDs. Central Govt. approved list of SC, ST and OBC categories as applicable at IIIT Lucknow. Copy of the Category Certificate (OBC/SC/ST/Pwd), issued by the competent authority, not below the rank of a Tahsildar, and must be attached. In case of OBC candidates, the certificate indicating the status regarding creamy layer must be issued on or after 01/01/2021. PwD certificate must have been issued by the competent authority as per Government of India norms.
