The Institute offers **B.Tech., M.Tech., M.B.A., Ph.D. and PG Diploma Programmes.** The Institute invites online applications from meritorious and highly qualified Indian nationals including the Persons of Indian Origin (PIOs) and Overseas Citizens of India (OCIs) for the faculty positions (under Four-Tier-Faculty-Structure) in the Departments of Computer Science (CS), Information Technology (IT), Management & Humanities (M&H) and Mathematics. Guidelines for reservations as per Government of India Norms will be followed.

- **III.** Based on the recommendations of the statutory Selection Committee and approval of Board of Governors the appointment letters shall be issued.

- 2) Candidates applying for more than one post/department have to submit separate application form for each post.
- 3) For each of the qualifications, professional experiences, achievements, etc., documentary proof in the form of self-attested photo-copies are to be attached with the application and original document is to be produced, if called for interview.
- 4) The originals documents must be produced at the time of interview and at the time of joining.
- 5) Incomplete application(s) / application(s) without necessary enclosures may not be accepted.
- 6) Copy of the category certificate (OBC / SC / ST / PwD), issued by the competent authority, not below the rank of a Tahsildar must be attached. In case of OBC candidates, the certificate indicating the status

regarding creamy layer must be issued on or after 01.01.2021. PWD certificate must have been issued by the competent authority as per Government of India norms.

- 7) The vacancies under EWS Category would be filled as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039/1/2019-Estt (Res), dated 31.01.2019. EWS vacancies are tentative and subject to further directives of Gol and outcome of any litigation. The appointment against EWS category shall be provisional and is subject to the Income and Asset certificate being verified through the proper channels and if the verification reveals that the claim of belonging to EWS is fake/false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of fake/false certificate. The Income and Asset Certificate issued by any of the authorities mentioned in the prescribed format shall only be accepted as proof of candidate's claim as belonging to EWS.
- 8) The eligibility, qualification, experience and requirements for the posts notified shall be governed by the guidelines issued by MoE (erstwhile MHRD) letter no. F.No.27-11/2011- TS.I, dated 23.04.2014.
- 9) The vacancies advertised are indicative and subject to variation at the time of interview. The Institute reserves the right to fill or not to fill any of the vacancies advertised. The Institute reserves the right to reject any or all applications without assigning any reason.
- 10) Any misleading wrong information supplied by the candidates may lead to summarily rejection of the application, if found subsequently, also the appointment will be cancelled.
- 11) The Screening committee shall short-list the eligible and desirable candidates, to be called for interview from amongst the applicants, based on specialization, availability of candidates, and requirements of the departments. The relaxation 05 years for SC/ST candidates and 03 years for OBC candidates with additional 10 years' age relaxation to persons with disabilities will be given in accordance with the Government of India Rules. Relaxation in upper age limit for those applicants, who are in Central Government or central Government Autonomous body, Ex-Servicemen, shall be admissible as per the Government of India rules. Further, the institute may consider relaxation in upper age limit in case of highly experienced and deserving candidate.
- 19) Person employed in Govt./Semi-Govt./Autonomous/PSU should also apply online and send the print out of completed application form along with all the relevant supporting documents and transaction slip with date, duly self-attested, THROUGH PROPER CHANNEL. Candidate may produce the NOC from their organization at the time of interview with an unambiguous certificate that (i) no vigilance case is pending/being contemplated against him/her.
