- 3. **Programmes** to be filled according to the list attached as **Appendix 'A'**. If the branch is not specified, leave the field blank.
- 4. The **fee** is to be filled according to the list attached as **Appendix 'B'**.
- 5. Hostel and Mess Charges are **NOT** to be included in the fees.
- 6. The details mentioned in the documents provided by students should be same in all their documents, for example their father's name should be same in all the supporting documents provided by the student.
- 7. Students are advised to continuously visit the website http://www.scholarship.up.gov.in for further updates and carefully read all the instructions mentioned under section Download Links (2021-22) on the above website.
