The Institute is being set up with financial contributions from Ministry of Education, Govt. of India; Govt. of Uttar Pradesh, and U. P. Electronics Corporation Ltd. as industry partners in the ratio of 50:35:15 respectively towards the capital expenditure.

The mission of IIIT Lucknow is to be a unique and world class nucleating “Apex Center of Excellence” in the area of Information Technology to enhance India's Technological strength in Information Technology. IIIT seeks to derive its strength from a linkage with sound Indian traditions of centuries past, and sets out to create knowledge-based resources in regional languages.

Initially, the administrative and academic activities of the Institute were started at the IIIT Allahabad, which was the mentoring Institute of IIIT Lucknow. The Institute shifted to its permanent campus at Lucknow in July 2019.



The permanent campus of IIIT, Lucknow is in 50 acres of land at Chak Ganjaria Region, Lucknow. The Institute is being set up with the financial contributions of MHRD, Govt. of India, Govt. of Uttar Pradesh, and U. P. Electronics Corporation Ltd. as industry partner. It is a couple of kilometers away from the International cricket stadium (along with many other sports facilities) which is being set up in Gomti Nagar extension.

The institute is surrounded by a 100 Acre IT City SEZ Lucknow project which is being developed by HCL Group. The IT city will provide direct employment to 25,000 with indirect employment to approx. 50,000 people.




Company Distribution



We have audited the attached Balance Sheet of the Indian Institute of Information Technology, Lucknow (Institute) as at 31 March 2020, the Income & Expenditure Account and Receipts & Payments Account for the year ended on that date under Section 19 (2) of the Comptroller & Auditor General's (Duties, Powers & Conditions of Service) read with Section 28 (3) of the Indian Institutes of Information Technology (Public-Private Partnership) Act, 2017. These financial statements are the responsibility of the Institute's management. Our responsibility is to express an opinion on these financial statements based on our audit.

2. This Separate Audit Report contains the comments of the Comptroller & Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards and disclosure norms, etc. Audit observation on financial transaction with regard to compliance with the Law, Rules and regulation (Propriety and Regularity) and efficiency-cum-performance aspects, etc., if any, are reported through Inspection Reports/CAG's Audit Reports separately.

3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining on a test basis, evidence supporting the amounts and disclosure in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.

4. Based on our audit, we report that:

(i) We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit;

(ii) The Balance Sheet, Income and Expenditure Account and Receipts & Payments Account dealt with by this report have been drawn up in the format of Financial Statements for Central Higher Educational Institutions prescribed by MHRD.

(iii) In our opinion, proper books of accounts and other relevant records have been maintained by the Institute.

(iv) We further report that:

(A) General

The Institute has not made any provision in respect of gratuity on Actuarial basis as required in AS 15.

(B) Grants-in-aid

The Institute received Grants-in-aid of ₹ 1855.00 lakh. After taking opening balance of ₹ 1484.43 lakh and Interest on grant account ₹ 82.74 lakh, the total fund available worked out to ₹ 3422.17 lakh. The Institute utilized ₹ 1358.13 lakh (₹ 1183.30 lakh for Capital Expenditure and ₹ 174.83 lakh for Revenue Expenditure) leaving a balance of ₹ 2064.04 lakh.

SCHEDULE 23 - SIGNIFICANT ACCOUNTING POLICIES

1 BASIS FOR PREPARATION OF ACCOUNTS :

The financial statements are prepared under the historical cost conventions, unless and otherwise stated and on accrual basis of accounting, except as reported in Para 2.

2 REVENUE RECOGNITION

2.1 Fees from Students (except Tuiton Fees) and Interest on Savings Bank Account are accounted on cash basis. Tuiton Fees collected separately for each semester is accounted on accrual basis.

2.2 Income from Land, Buildings and Other Property and Interest on Investments, if any are accounted on accrual basis.

3 FIXED ASSETS:

Fixed assets are stated at cost of acquisition including inward freight, duties and taxes, incidental and direct expenses related to the acquisition, installation & commissioning.

Fixed assets are valued at cost less accumulated depreciation.

4 INTANGIBLE ASSETS:

Computer software are grouped under Intangible Assets.

5 DEPRECIATION:

Depreciation on fixed assets has been charged on Straight Line method at rates as prescribed in the Uniform Accounting Standard for all education institutions by MHRD. Depreciation is provided for the whole year on additions during the year.

Where value after depreciation of Tangible assets is less than 5% of original cost, such assets is carried in Balance Sheet at 5% as residual value and will not be further depreciated.

Assets, the individual value of each of which is Rs 2000 or less (except Library Books) are treated as Small Value Assets, 100% depreciation is provided in respect of such assets at the time of their acquisition. However physical accounting & control are continued by the holders of such assets.

6 STOCKS:

Expenditure on purchase of laboratory material, medicines, stationary items and other stores is accounted as revenue expenditure, except that the value of closing stocks held on 31st March 2020 is set up as inventories by reducing the corresponding Revenue Expenditure on the basis of information obtained from respective Departments. They are valued at cost.

7 RETIREMENT BENEFITS:

8 GOVERNMENT GRANTS:

8.1 Government Grants are accounted on realization basis. However, where a sanction for release of grant pertaining to the financial year is received before 31st March 2020 and the grant is actually received in the next financial year, the grant is accounted on accrual basis and an equal amount is shown as recoverable from the Grantor.

8.2 To the extent utilized towards capital expenditure, (on accrual basis) government grants are transferred to the Capital Fund.

8.3 Government grants for meeting Revenue Expenditure (on accrual basis) are treated, to the extent utilized, as income of the year in which they are realized.

8.4 Unutilized grants (including advances paid out of such grants) are carried forward and exhibited as a liability in the Balance Sheet.

9 TAXATION:

The income of the Institution is exempt from Income Tax under Section 10 (23C) of the Income Tax Act, 1961. No provision for tax is therefore made in the accounts.


