<u>Item No. 3.3:</u> To apprise the status of construction.

It was apprised by the General Manager, UPRNN that the first phase of work is in the final stage of completion and the work related to Sewage, Water tank, Networking and some minor works are to be done. As per utilization certificate, 95% of the work has been completed. UPRNN has informed that due to the monsoon, the construction activities are getting hampered and it will take around six months in finalizing the sewage work. UPRNN also informed the members that as per the guidelines received from Pollution & Control Board, it should prefer setting up a STP over the existing proposal of connecting the Institute sewerage pipeline with LDA sewerage line as this will be environment friendly. For the STP work, UPRNN shall prepare a detailed proposal and send the same to the Institute for consideration. As suggested by Dr. Tripathi, the Institute may forward the proposal of STP to Dr. Vinod Tare, IIT Kanpur for technical vetting to which UPRNN has provide its consent. The construction of STP would be done within the allocated budget for sewage work without any further cost escalation.

The officials of the PMA discussed about a conceptual plan regarding drainage works of the campus. It was resolved that the PMA will put up this proposal (with all the relevant drawings and contours plans) also for vetting by Dr. Vinod Tare.

The members of BWC took a tour of the campus and observed that there are no proper signage installed anywhere in the campus. The PMA conveyed the work may be completed within 15 days. The PMA was also communicated to repair the minor construction flaws viz. seepage, road breakage, maintenance of landscaping, closing of open spaces in the buildings, etc.

<u>Item No. 3.4</u>: To apprise the Head wise details of Balance work and details of funds in respect of the First Phase of the work amounting to Rs. 104.42 Cr.

It was communicated by the member secretary that the Institute has paid 90% of the sanctioned amount of first phase of work. As per the BWC resolution no. 2.3 of the Second meeting of BWC dt. 05.11.2020, out of the balance amount, 5 % may be released after submission of the agreement between UPRNN and construction agency alongwith utilization

certificate and final 5% payment shall be made after the process of work completion and Handing/Taking over of the building.

It was informed to the BWC that the agreement(s) were submitted by PMA i.e. UPRNN to the Institute. As per the utilization Certificate by the PMA, approx. 100% of funds released so far have been utilized as on 31.03.2021. BWC while considering desired that PMA should provide the commitment of completion of the first phase of work and a firm date in this regard may be apprised to the Institute.

The BWC also took note of the testing report submitted by UPRNN and observed that the last testing was done in the year 2020. The members resolved that a technical/quality audit of the project including civil and electrical works may be done by the experts of IIT Kanpur and the reports may be placed before the BWC to which the officials of PMA and construction agency also provided their consent. This shall be required to be done before the handing/taking over of the first phase of the work.
