Scope of Work

IIIT Lucknow is looking to migrate its Websites based on WordPress/PHP-MySQL based environments with a partner that can provide services of hosting, support and maintenance. The scope of work associated is detailed as below:

Hosting Requirements:

- Setup of a reliable, fault-tolerant and high-availability environment on a renowned hosting platform like AWS, MS-Azure, GCP or any equivalent.
- The platform should be scalable and should support hosting of up to 5 websites based on either Wo rdpress/PHP-MySQL based platforms with moderate to high volumes of traffic.
- The account should be catered for in such a manner that the ownership can be transferred to IIIT, Luck now as and when required without any impacts thereof.
- The infrastructure should support 1 TB of storage.
- Security and availability of the hosted web applications is a prime requirement.
- DNS & DNR Services may be required additionally.

Deployment Requirements:

- The deployed web application would be subjected to changes every now and then. Thus it is recomm ended to have a renowned and stable CI/CD pipeline provider.
- IIIT, Lucknow recommends the usage of code versioning tools like GitHub / GitLab / Bit Bucket to be ut ilized for the deployment pipeline.
- The used platform to be ensured to follow defined standards of the best practices.
- Defined access management in place for the deployment and versioning tools to be in place for managing the repositories and code deployments.

Security Requirements:

- The web apps to be secured over the network via SSL certificate from a provider.
- Renowned firewall service to be in place to ensure monitored traffic and accesses.

- Other general guidelines of HTTPS, HSTS, SSL & TLS to be followed.
- Regular audit reports to be submitted.

Access Requirements:

- Secured access to code and database environments to be created / maintained for all authorized sta ff / students / other relevant personnel from IIIT, Lucknow.
- The accesses to different components to be manageable from a centralized system which in itself is o ver a secured platform and managed with due security measures.
- VPN based access would be an added preference.

Other Additional Requirements:

- Regular maintenance and audit reports for the hosting environment to be in place.
- Setup audit reports to be submitted upon completion and setup of each application.
- Training of IIIT, Lucknow authorized personnel / staff / students for the defined environment to be in place.

Technical Eligibility Criteria:

- 1. The bidder must have at least 7 years of experience in the field of similar types of services/ IT solution s and Managed services.
- 2. The bidder must possess an ISO 27001 certificate

Other Terms & Conditions:

Contract Duration:

• The contract duration shall initially be for one year with maximum extension period of one-year subject to the satisfactory performance during the period of contract.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
