1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

3. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Eligibility Criteria for Technical Qualification of Bidders:

Bidders are required to meet the following criteria, in addition to the terms and conditions specified in the tender document:

Minimum Annual Turnover: The bidder must have a minimum annual turnover of ₹40 Crore for each of the financial years 2021-22, 2022-23, and 2023-24. A certificate from a Chartered Accountant (CA) confirm ing this turnover must be submitted along with the technical bid.

Experience: The bidder should have at least 7 years of experience in providing security services to IITs, III Ts, NITs, IISERs, IISc, or Central Universities. The bidder must submit two copies of orders, with the time pe riod between the two orders covering a total of 7 years. Additionally, the later order must be from at least 2021, 2022, 2023, or 2024.

For example: (a) If the bidder submits one experience document from 2016 and a second order from 2022, this meets the 7-year requirement.

OR

(b) If the bidder submits one experience document from 2015 and a second order from 2021, this also mee ts the requirement.

OR

(c) If the bidder submits one experience document from 2017 and a second order from 2023, this fulfills th e 7-year requirement as well.

OR

(d) If the bidder submits one experience document from 2018 and a second order from 2024, this fulfills th e 7-year requirement.

Pre-Bid Meeting Attendance: Attendance at the pre-bid meeting, as per the scheduled date and time m entioned in the bid document, is mandatory for participation in this tender. Failure to attend the pre-bid m eeting and site visit will result in the rejection of the bid as non-responsive. Bidders who attend the pre-bid meeting must submit the following document to be considered valid: (i) An authorization letter on the com pany letterhead stating that the person/employee attending the meeting is authorized to do so.

Location: The bidder must have its registered/branch office in Uttar Pradesh. Documentary proof of the o ffice's location must be submitted.

PAN India Presence: The bidder must have a PAN India presence. To verify this, a valid PASARA certifica te from at least five states in India must be submitted with the bid.

MSE Certification: MSE bidders must submit a valid certificate, not older than Classification Year 2024-2 5, as well as Type of Enterprises as Micro or Small Enterprises in order to avail of the Purchase Preference under the Public Procurement Policy for Micro and Small Enterprises (MSEs). Furthermore, no EMD is requir ed to be submitted by any bidder.

Bidders who do not meet the above criteria, in addition to the terms and conditions in the tender documen t, will not be considered technically qualified.

6. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

7. Past Project Experience

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. The capping on PF and ESIC shall be applicable as per the Central Government norms and the succ essful bidder shall have to following all the statutory compliance as per Labour Law, Minimum Wag es Act, etc.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत कामाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
