GENERAL TERMS AND CONDITIONS:

- 1. The Bid should be accompanied by the following documents:
 - i) Location Map.
 - ii) Copy of agreement for acquisition of property.
 - iii) Approved plan of the offered premises with exact measurement for carpet area.
- 2. The premises offered should be in ready condition and the owners of the premises will have to hand over the possession of premises within 15 days after acceptance of their offer. The offer should be valid for a minimum period of 36 months from due date of opening the tender. It may be noted that no negotiations will be carried out except with the lowest tender and therefore most competitive rates should be offered.
- Tenders received after the due date and time for whatever reason, shall not be entertained and this office shall not be responsible for any loss or delay in delivery of tender documents.
- 4. The building should have running water supply & preferably assured power back-up and on continuous basis.
- 5. The premises offered should consist of the minimum amenities/ facilities as mentioned in Annexure-II enclosed to this tender notice.
- 6. The premises offered should have construction approvals from all Central / State Government Department as may be necessary by the local authorities.
- 7. The Owner would be required to get the premises insured against all types of damages due to various causes during the entire period of rent contract.
- 8. All the common amenities available in complex shall be made available to the IIIT Lucknow.
- The legal owner of the building should provide adequate parking space.
