# Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्ते

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

The OEM, i.e., M/s Hitachi, or its authorized service partners are required to submit a Price Reasonability C ertificate on the company's letterhead stating that they have not quoted the same CAMC at a lower rate th an that being offered to IIIT Lucknow to any other customer, nor will they do so during the validity of the of fer or until the execution of the work order, whichever is later.

If there is no service partner authorized by the OEM, i.e., M/s Hitachi, for the CAMC of VRF units, then the O EM must certify this on their letterhead.

Authorized service partners of Hitachi, if they wish to participate in this bid, must submit an OEM Authoriz ation Letter stating that M/s \_\_\_\_\_\_ is authorized by Hitachi to participate in the bid (Bid No. \_ \_\_\_\_\_ dated \_\_\_\_\_\_) published by IIIT Lucknow for the Comprehensive AMC of Hitachi VRF units.

The total HP of the air conditioners, i.e., 426 HP as specified in the tender document, is based on a prelimin ary assessment conducted by the buyer. The OEM or its authorized service partner is advised to visit the In stitute prior to bid submission to independently verify and ascertain the actual HP of the installed AC units. After the award of the order, if the actual HP exceeds the figure mentioned in the tender (i.e., 426 HP), no additional payment shall be made. However, if the actual HP is lower, the cost benefit shall be passed on t o the buyer, and payment will be made based on lower value.

Bidders are advised to visit the Institute to inspect the functionality of the ACs, if required. Once the CAMC is awarded to the bidder, no cost related to the repair or replacement of any faulty parts, if found, shall be borne by the Institute under any circumstances.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export

experience.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

# All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
