1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. 4. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 5. An OEM undertaking, on its letterhead, shall certify that the offered equipment is based on the latest technology, no upgraded/revised model has been launched as on the bid date, and spare parts shall remain available for at least ten (10) years.
6. The bidder shall furnish OEM-certified after-sales service details, including the service centre address, office telephone number, authorized service engineer(s) with mobile number and e-mail ID, and a dedicated toll-free service support number.
7. The bidder shall offer only products that are not obsolete and have a minimum residual market life of ten (10) years. An OEM declaration confirming that the product shall not be declared End-of-Life (EOL) during this period shall be submitted.
8. The Bidder or its OEM (directly or through authorized reseller(s)) shall have regularly manufactured and supplied the same or similar products to Central/State Government Departments, PSUs, or publicly listed companies for the last five (5) years. Relevant supply orders/contracts for each year shall be enclosed. For bunch bids, this requirement shall apply to the primary product of the highest value.
9. The quoted product shall be listed on the OEM's official website, and the corresponding webpage link shall be provided.
10. The Buyer may require demonstration of the quoted product(s) during technical evaluation. Failure to comply may render the bid liable for rejection.
11. Prices shall be quoted on an F.O.R. destination basis, inclusive of all applicable taxes and duties. Applicable GST and HSN Code shall be clearly indicated. The Bidder/OEM shall have a dedicated/toll-free service support number.
12. The Bidder/OEM shall furnish a Service Support Escalation Matrix with contact details of the responsible personnel.
13. The Institute reserves the right to reject any bid for non-submission of any document, certificate, declaration, or other requirement prescribed in the Bid Document, ATC, or Corrigendum.
